Criteria considered when determining whether a request may be voluminous and burdensome include, but are not limited to, the following:

- A legal request for 15 numbers or more requesting subscriber/billing/credit/features, or 30 numbers or more requesting subscriber information.
- The response to a legal request amount to 100 pages or more of print or electronic copy; or
- The legal request requires one (1) or more hours to process in a civil case.
- Voluminous and burdensome charges may apply to a single legal request or multiple legal requests from the same agency associated with the same case or cause number, as determined by Windstream Services, LLC.

All civil costs billed are due and payable prior to the delivery of documents to the requesting party.
