Description of the Planned Network Change(s):

The DMS switch, located at 11852 N Bloxham St, Brooker, FL 32622, will be decommissioned, powered down, and removed from Windstream's network as a result of network modernization and consolidation. All traffic will need to be routed to the BRKRFLXAPS0 Meta Switch, located at 11852 N Bloxham St, Brooker, FL 32622. Windstream BRKRFLXADS0 A-Block of 352-485 is being moved to BRKRFLXAPS0.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the BRKRFLXAPS0 Meta Switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the BRKRFLXADS0 DMS switch will be required to reposition the codes to the BRKRFLXAPS0 Meta Switch.

All ASRs for the BRKRFLXAPS0 Meta Switch must be received no later than July 16, 2023, in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the BRKRFLXADS0 DMS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the BRKRFLXADS0 DMS switch (on or after July 17, 2023). This will serve to guide interconnect re-routes of Windstream traffic for native codes currently served by the BRKRFLXADS0 DMS switch to reflect the BRKRFLXAPS0 Meta Switch as the new home switch. All ASRs for the BRKRFLXAPS0 Meta Switch must carry the project code of BRKRFLXAPS0.
